Purpose of Report

The purpose of the report is to provide Council with the feedback received on the Riverside Precinct Refined Concept Designs through the Public Exhibition period; to seek Council endorsement of the Riverside Precinct Refined Concept Designs prior to progressing to the detailed design stage of the project; and to update Council on the financial status of the project.

Background

In 2007, AlburyCity endorsed the Murray River Experience Master Plan. This Master Plan identified future improvements along the Murray River and Lake Hume, with the main objectives to:

- strengthen the relationship between the community and the Murray River;
- provide greater access to the Murray River;
- provide quality amenities in all open spaces;
- promote and develop a diversity of experiences; and
- significantly improve the health of the Murray River.

The development of the riverside area behind the Albury Swim Centre (Hume Street to Bungambrawatha Creek), known as the Riverside Precinct, was one of the key projects identified in the Murray River Experience Master Plan. Concept designs for the Riverside Precinct were developed in 2016, which could accompany future grant applications (attachment 1).

In 2018, AlburyCity applied for funding under the Regional Growth, Environment and Tourism Fund (RGETF) for projects included in the Murray River Experience Master Plan. The Riverside Precinct project was one of the projects included in this application. This application was successful and subsequently \$4.7M was allocated to this project.

In March 2019, a consultant was appointed to progress the concept design into detailed construction documentation. The initial component of their brief was to review the 2016 concept designs (attachment 1) in context of the feedback received during the initial community consultation and the current design ideology for the area.

The key issues addressed through this process were:

- retention of greenspace;
- retention of significant trees;
- improved access to the river; and
- rationalisation of car parking.

The refined concept designs (attachment 2) address these identified community issues.

To ensure there was consistency in the design development of the wider section of the Riverside Parks, the opportunity was taken to expand the refined concept design area to provide a master plan of the entire precinct, including the entire area between Mudges Canal and Hume Street, which is beyond the initial RGETF scope of works. More specifically, the Hovell Tree Park pizza oven upgrade, also one of the projects associated with the RGETF program, was included to ensure that the landscape areas around the Hovell Tree Park pizza oven shelter were consistent with the Riverside Precinct.

It must be noted that not all elements identified in the expanded refined concept design will be constructed through the RGETF funding, and some future stages of the updated designs will be subject to future grant applications and/or budget processes.

Community Engagement

This project has been identified for community engagement on two previous occasions:

- Murray River Experience Master Plan in 2007; and
- Riverside Parks community consultation in 2017.

During June and July 2019, the refined concept designs were also presented to several key government agencies seeking input into the designs.

The agencies engaged during this process included:

- NSW Fisheries:
- NSW Crown Land;
- NSW Office of Environment and Heritage;
- Natural Resources Access Regulator and NSW Roads; and
- Roads and Maritime Services.

The purpose of this consultation was to identify key elements of the concept design that may impact any future request for approval. Several elements were identified as potential barriers to approval which were forwarded to the consultant to inform the design. These potential barriers have subsequently been addressed through the refined concept designs.

Other organisations that were consulted during this period include:

- Albury Wodonga Farmers Market;
- Aligned Leisure;
- Park Run; and
- Albury Tigers Football Club.

Albury Wodonga Farmers Market are very interested in having a presence in the precinct and Aligned Leisure were consulted about the potential to utilise existing infrastructure to service the Riverside Precinct.

The refined concept designs public exhibition process was the third and most recent opportunity for the community to provide feedback (23 September - 1 November 2019). This resulted in 15 submissions being received via email (attachment 3), with a summary of the feedback received outlined in Table 1 below:

Key issues identified through the public exhibition process:

- **Generally**, there is support for the refined concept designs. There were a number of positive comments on social media posts however these do not necessarily result in comments received through formal submissions.
- Water park a small water feature area has been included in the concept design however will not be constructed in Stage 1. Through recent feedback during other master planning process, splash parks have been a consistent request. Further investigation is required to identify a suitable location within the City for a splash park. The Play Space Strategy will consider the construction of a large splash park as a future stage of the Oddies Creek Play Space.
- Trees and vegetation several comments received on shade, loss of green space and the extent of hard surfaces. There is currently over 130 new trees identified in the designs (the number will be confirmed during the detailed design stage). The refined concept designs also

identify the retention of significant River Red Gums along the streambank. These were identified for removal in the 2016 concept design. The detail of the planting palette will be confirmed during detailed design.

- Green space/hardstand area The hard stand areas are required to improve accessibility to the site and to improve connectivity to key locations within the site. Hardstand is also included to facilitate events such as Albury Wodonga Farmers Markets. The majority of this hardstand has been confined to existing road and path alignments. The Peninsula area boardwalk is also being reviewed with a gravel path being considered as an alternative.
- Accessibility Accessibility was a key component of the design brief. Handstand pathways
 and ramps are utilised to link key areas to ensure compliance with the Disability Discrimination
 Act (DDA). Accessible seating is also included in the designs.
- River access River access where people can interact with the water has been identified in two locations.

With the comments received through the public exhibition process there were no significant changes required to the refined concept designs. These comments have been forwarded to the consultants for consideration through the next level of design.

Regional Growth Environment and Tourism Fund

The Albury Riverside Precinct is the signature project for the \$10.1M Regional Growth, Environment and Tourism (RGETF) grant program. A summary of projects is included below in Table 2, with identified grant funds and Council contribution.

As outlined in the above table, Council's contribution to the Riverside Precinct is \$255,000. This was the estimated cost for the detailed design process as identified by the consultant during the development of the 2016 concept designs.

Expenditure year to date for the Riverside Precinct at the end December was \$151,343. The revised budget for the completing the detailed design phase is \$347,000. With the increase in detailed design costs the remaining funds available for construction has reduced to \$4,322,000.

Issues

Albury 2030 Plan

This project is in alignment with following goals:

Theme One - A Growing Sustainable Economy

1.2 Improve visitor and residents' experiences.

Theme Three - A Caring Community

- 3.3 The health and wellbeing of the Albury community improves.
- 3.4 Albury offers a diverse and accessible range of facilities and activities for all ages.

Strategies

This project has been identified in the Murray River Experience Master Plan and aligns with the AlburyCity CBD Master Plan.

Wodonga City Council's Gateway Island Master Plan has been considered throughout the concept design review phase to ensure that the concepts identified in both plans are aligned.

Community Impact

The provision of improved community infrastructure and open space along the river provides a positive impact for both residents of and visitors to Albury.

Environmental Impact

The concept design process has involved consultation with key river stakeholders. Environmental issues identified during this consultation have been considered during this design process. In addition, the designs have also sought to minimise the loss of native vegetation, as well as include a suitable replanting program using a range of suitable riparian indigenous species.

A Review of Environmental Factors is currently underway based on the refined concept plan. Environmental approvals will be obtained once the detailed design is completed.

Financial Impact

This project has funding identified as part of the \$10.1M RGETF with an identified budget of \$4,669,000 (design \$255,000 and construction \$4,414,000). The increase in design costs has reduced the construction budget to \$4,322,000.

In addition, a portion of the \$502,650 for the wood fired oven project budget (\$270,650) will be allocated to construction of the landscape elements of this project, with the balance of the wood fired oven budget (\$232,000) allocated to the structural elements of that project (storage area, extension

of the shelters, new wood fired ovens). Therefore, the total available construction budget is currently \$4,592,650.

A more holistic approach through the design process was undertaken with the inclusion of the wood fired oven area and the Noreuil Parade roadway in Hovell Tree Park to Mudges Canal. As a result, the design area has expanded which has in turn has increased the probable cost estimates. Table 3 outlined below provides details of probable cost based on the refined concept designs (attachment 2).

From a financial perspective, Table 3 shows the revised Riverside Precinct costs (\$8,720,000) are \$4,051,000 greater than the initial budget estimates for Riverside Precinct that were identified in Table 2 (\$4,669,000). The increasing costs are primarily attributable to the expanded scope to include Stages 2c, 3 and 4. In addition there have been some increasing costs associated with the refined design for Stages 1, 2a and 2b, as well as an increase in construction costs given the initial budget was forecast back in 2016 based on preliminary concepts.

These anticipated project costs will need to be further refined following completion of the detailed designs, and the true costs will only be better known once a tender has been released to test the market.

Delivery Staging

It is anticipated that the increasing costs associated with the project can be accommodated by implementing a staged delivery program over multiple financial years, using currently available funds to deliver Stages 1 and 2a, and then using future capital initiative budgets to deliver Stages 2b, 2c, 3 and 4 (subject to future Council budget deliberations).

To manage the potential risk associated with the contract costs exceeding the available budget, an initial tender will be released and structured using separable portions. This will allow the true market costs for each stage to be better understood, whilst only releasing those stages that can be accommodated within the available budget. Therefore it would be prudent to move to detailed design for at least stages 1, 2a and 2b.

The currently available construction budget of \$4,592,650 will be used to primarily complete Stages 1 and part of 2a in 2020/21, whilst the budget to complete the remaining stages will be scheduled into subsequent years for Council consideration. Table 4 below summarises the proposed budget allocations and project stages to be completed over multiple financial years.

Risk

- Business Risk The project construction budget was provided to the consultant as part of the
 design brief document. At the completion of the refined concept design process an updated
 probable cost estimate for the expanded project scope has been developed (Total for all stages
 as designed is \$8,720,000). Staged construction and funding options are discussed previously
 in this report.
- Corporate Risk This project is in a high-profile riverside park, and there are a range of
 community expectations that need to be managed whilst giving effect to the long-term vision
 for the precinct. There will be public scrutiny on the project through both the design and
 construction phase. Keeping the community informed through the website and social media
 will assist in minimising corporate risk.
- Environmental Risk A Review of Environmental Factors is currently underway and environmental approvals will be obtained once the detailed design is completed.
- WHS and Public Risk This project will improve public safety and accessibility at the site. WHS
 and risk management have been considered at a high level for the concept planning phase.
 Further risk management consideration will be undertaken during the detailed design phase
 and during construction when they occur.
- Delivery Program Risk Stages 1 and 2a are funded through a combination of Council and RGETF program funds. Future works identified in the precinct masterplan will be considered in future budgets, and as grant programs become available.

Options

Albury Riverside Precinct Refined Concept designs

- Endorse the refined Riverside Precinct Concept Plan noting the feedback received during the public exhibition, which will allow staff to continue the detailed design. This is the preferred option.
- 2. Do not endorse the refined Riverside Precinct Concept Plan and not progress to detailed design. **This is not the preferred option** as significant consultation has occurred with key stakeholders during the refinement of the concept design. Seeking community comments

through the public exhibition will assist in finalising the concept plan prior and commencing detailed design phase ready for construction.

Delivery options

- Endorse a staged delivery program as outlined in Table 4. This is the preferred option as it
 would deliver the design intent of the project and fulfil our RGETF grant fund obligations.
 Additional funding would be required to complete additional project scope components, which
 will be included in future budgets for Council consideration.
- 2. Do not endorse a staged delivery program. **This is not the preferred option** as it will significantly impact the ability to deliver the design intent of the project and not fulfil our RGETF grant fund obligations.

Conclusion

The Riverside Precinct project is a key improvement identified in the Murray River Experience Master Plan. Concept designs for the Riverside Precinct were developed and endorsed in 2016 pending comments received through the community engagement process.

The more recent Public Exhibition process for the refined concept designs received 15 submissions. The issues with the design identified in the submissions have either been addressed in the refined concept designs or have been forwarded to the consultant for consideration during the detailed design phase. As there are no major changes required to the Albury Riverside Precinct Refined Concept Designs, it is proposed that the designs placed on public exhibition be endorsed.

Staged options for construction have been considered to accommodate additional scope and the rising costs observed since the preliminary concepts were costed back in 2016. There may also be some further refinement in costings following the completion of detailed designs, although the full extent of any variance would only be fully realised following the release of a tender for construction.

Recommendation

That Council:

- a. receive and note the community engagement comments received and responses;
- b. endorse the Refined Riverside Precinct Concept designs and proceed to detailed design for Stage 1, 2a, and 2b; and
- c. endorse a staged delivery program that will be included in future budgets and as grant funding becomes available.
